Town Council Notes October 2, 2023 Town Manager Report:

Paderewski Park

• The Brick Utility Building at Paderewski Park, next to the pavillion that is used by the Rec. Department for summer camp, has recently undergone some minor repairs and upgrades. This renovation work was performed by Tilcon as a community project that coincided with their recent 100th anniversary celebration. I have included pictures in the agenda packet.

Honor Heights Sewer Project Update -

The following work remains as of October 1, 2023.

- Installation of 50 LF of main line in the easement area near Robidoux Road – Work scheduled to be performed on October 3, 2023.
- Installation of 4 service laterals work scheduled to be performed on October 2nd and 4th.
- General Project Restoration work scheduled to be performed October 5th thru October 13th – sidewalk, trench patch repair and lawn restoration – weather permitting.
- Testing of the system work scheduled for the week of October 16th thru October 20th, with final inspection by the Town WPC and Roadways.
- The suggested schedule for setting Assessment and Connections are as follows: October 16, 2023 – Town Council schedules Special Meeting for November 27, 2023 - Work Session to review Honor Height Sewer Project. November 27, 2023 - Town Council Work Session to Review Honor Heights Sewer Project and sets Public Hearing for Final Assessment - December 19, 2023, with Snow Date of January 2, 2024. December 19, 2023/January 2, 2024 – Conducts Public Hearing for Final Assessment. January 2, 2023/January 17, 2024 - Set Final Assessment. February 20, 2024 - Final Assessment Documents Filed with the Town Clerk - Appeal Period-30 calendar days. March 25, 2024 - Assessment Payments are due. April 1, 2024 - Residents will be permitted to connect to the public sewers.

Town Council Notes October 16, 2023 Town Manager Report:

Announcement of Special Meeting on Debt Service

- The debt service special meeting will be held Monday, October 23, at 6:00pm in the Council Chamber.
- The purpose of the meeting is for the Town Council to review an error that was made in the calculation and to understand the impact of the revised numbers.
- Debt service includes many projects not just the middle school, so the discussion for the Town Council is a broader (big picture) conversation around the impact the correction may have on the budget process and fiscal policy going forward.
- Rob Buden will be on hand for the 23rd to explain the revised numbers and the impact on the budget process going forward.

ARPA Funding Update

- I will run through the updated list to discuss which items are still unobligated.
- As you may recall ARPA funds need to be obligated to projects by December of 2024, which is to say they need a public hearing and approval by the TC in order to be considered obligated.
- All ARPA dollars must be spent by December 2026.

Landfill Update

- The landfill closure project is making good progress and is expected to conclude by the end of December 2023. However, weather and site coordination could play a role in extending the timeline.
- I have included September's report from our consultant LEA on the tracking of materials and state approval process. LEA has confirmed CT DEEP has given approval for the reuse of existing material on-site for cover material.
- With this approval, LEA is still on track to have the southeastern portion of the site completed by 10/16. The Town can then relocate stockpiled materials to the southeast portion of the site.
 I have included pictures of the site that show the southeastern portion with millings that will serve as space for the Roadways Department to store and stockpile materials.

Simon Roofing and Sheet Metal for a cost of \$87,720. Overall, the contractor did a great job with the installation and the Town will have a 20 year warranty on the roof.

Norton Park Gazebo Update

- The current gazebo is approximately 15 years old and was installed without a concrete slab for a foundation. Over the years moisture has come up through the ground and weakened the structure to the point where it needs to be replaced.
- The gazebo is a nice amenity for Norton Park that gets a lot of use from patrons who visit the park and those individuals and families that book it for special events.
- The Town is partnering with the Petit Foundation to install a new gazebo at the same location along with a concrete slab to enhance the longevity of the structure. The new gazebo is of the same size and similar design. The project is expected to be completed by the end of October.

Plainville has an on-demand policy for the collection of bulk pickup. Residents who currently have curbside waste and recycling collection are eligible to receive one bulk pickup per calendar year free of charge for acceptable large items that do not fit in normal waste collection.

Please visit the Town of Plainville website at www.plainvillect.com for a complete list of acceptable bulk items and instructions on how to request a pickup.

LEAF COLLECTION

Leaf collection will begin during the week of October 25, 2023 until December 2, 2023 (weather permitting).

Residents must rake their leaves to the curb (not on the street) as early as possible without blocking sidewalks or walkways. Grass clippings, sticks, and stones will not be collected. 

"Ask Sheila"

Q-1: My friend told me about a way to save money on my Medicare costs, called "The Medicare Savings Plan". If I apply for this, will I have to pay anything back? *A-1: The Medicare Savings plan is based on your income level. If you qualify, you will save money on your Part B premiums, drug coverage costs and possibly on medical co-pays. None of the benefits will have to be repaid.*

Q-2: I have a Medicare Advantage Plan. My doctor's office, which is in my network, sent me an Invoice for a balance due. I already paid the office visit co-pay, do I have to pay this additional charge?

A-2: No, the Doctor's office is not allowed to 'Balance Bill' for any additional costs. You should call your Advantage plan and let them know this happened.

Q-3: I have just Medicare and no Advantage or Supplement Plans. Can I see any doctor I want ?

A-3: Not all Doctors accept Medicare. You should ask the Doctor when you call to make an appointment if he accepts Medicare. A doctor who has opted out of Medicare can't bill Medicare for services you receive and isn't bound by Medicare's limitations on charges. You enter into a private contract with the doctor, agreeing to pay his bills directly and in full. You can't claim reimbursement from Medicare under this arrangement.

THE CONNECTICUT UNIFORM POWER OF ATTORNEY EXTRA! EXTRA! READ ALL ABOUT IT!

Connecticut has a new Power of Attorney (POA) form that is in effect right now. Is my old POA still good? Will my old POA need to be changed? Does the law require me to get a new POA? I am sure these are just some of the questions everyone may have when first learning about this change in the law. Well, you have come to the right place. Answers to these questions and more are right below... so let's go!

First and foremost if you already have a POA it is still enforceable. This new law does not require you to get a new POA. The new law cleans up some of the deficiencies that have been on the books since 1965 while providing more flexibility for people granting power of attorney. Perhaps the most noticeable change is that the new POA does not need to be designated as "durable". In the past, you would have to specifically state that a POA would survive incapacity. Now it is presumed in the new POA, which makes sense because that is most often exactly when you need a POA.

The powers granted in the new POA are much more customizable than the old version. In the past, when an individual granted Power of attorney to someone and needed that person to undertake some specific act, not listed in the POA form, they would have to amend the POA to specifically state their desires. Even that may not have accomplished what they wanted and then they would be required to provide an additional certification or other required proof. All of which would be very cumbersome and potentially a fatal flaw if the person were to die during the process. Now, the new POA form lists additional functions and provides a catch-all section that can be amended right on the form to include the desired transaction. Essentially, the new POA form consolidates all the precautions into one form.

So with all these new powers there needs to be extra safeguards. The principal granting the power now has the benefit of naming multiple agents so that each may watch over the other. Also, each agent is tasked with acting in the best interest of the principal. So if one agent is acting in a manner detrimental to the principal they can be stopped. There were obviously too many horror stories going around about people losing everything after granting power of attorney for the legislature to ignore any longer.

Agents will still be afforded the protection of "hold harmless" clauses, which protect them from being sued by unhappy creditors or family members of the principal. However, agents more than ever are liable to the principal if they act in a manner against the principal's desires. The new POA really seeks to provide checks and balance that were not there before.

Financial institutions will also be required to recognize these new POAs under the law. Under the old law POAs were merely looked at as private agreements between people. Now they are a more formalized act of law that must be followed unless the bank has a valid concern that the agent is not acting in good faith and/or there is some attempt at fraud. Again, the legislature was looking to clean up the red tape and streamline transactions where time is of the essence.

So there it is... all of the highlights from the new Connecticut Uniform Power of Attorney. While the new law does not affect old POAs, it certainly gives people a few reasons to go and get a new one. Whether you want to make sure your agent does not have too much power or you want to eliminate some of the red tape it might be time to update your POA. Everyone's situation is unique, so if you are not sure what you may need do not hesitate to contact a licensed attorney. Happy Thanksgiving!

5. Acne Management: Cannabidiol (CBD) shows great potential in the management of inflammatory acne. CBD helps to reduce local inflammation and regulate the production of sebum (oil produced by our skin). Additionally, due to its antibacterial properties, CBD may inhibit the growth of acne-causing bacteria.

6. Allergies & Skin Sensitivities: Those with sensitive skin or allergies may find relief with cannabis-infused skincare products because these compounds are generally well-tolerated and are soothing to most skin types.

7.Potential Side Effects: While cannabis-based skincare products are generally safe for most people, it's important to consider potential side effects like skin irritation or allergies. Patch testing a small amount of the product on a discreet area of skin is a good practice to ensure compatibility. Additionally, most topical cannabis products have low THC content (< 0.3% THC) and are not absorbed systemically in quantities that would cause psychoactive effects or impairment.

While more research is needed to fully understand the efficacy of cannabisderived compounds in skincare, this is an exciting advancement in the world of skin health. Connecticut Households Waste Over \$800 Worth of Food Per Year, **Reveals Study.**

Only 1/4 of people know what the useby date means.

South Carolinians are the most wasteful in the nation.

West Virginians are the least wasteful. Winter tends to be a very foodie time of year; we've had Thanksgiving and Christmas, with all the turkey excesses. All across the nation, families have filled up the freezer, stocked up the fridges, and got supplies for each foodfocused gathering. But what happens to everything we buy? Are we as good as we could be about using everything up? Or are we guilty of food waste?

Cherry Digital, a communications agency, wanted to find out just how wasteful we Americans are, and surveyed 3,200 of us to find out how much we throw away this past year...

The first discovery was that Connecticut households waste \$874 worth of food annually, or in other words, almost a quarter (22%) of their food each month - because it's gone past its expiration date*. The national average was \$907, meaning Nutmeggers are among the least wasteful in the nation.

Broken down by state, the survey found that South Carolinians are the most wasteful, who get rid of \$1,304.68 worth of food every year. The leastwasteful state is West Virginia, who's residents only throw away \$404.90 worth of their annual groceries.

So why are we being so wasteful? It seems that the misunderstanding of food labelling might be a huge factor. The survey found that nearly half of respondents (48.9%) won't eat food that's marked as past its sell-by date - but perhaps that's because they are misinformed about what the sell-by date actually means – it is the last date by which it must be sold in a store; however, after that, it's still good to eat (even if it's past what's marked as the use-by date).

Again, the label – use-by date – caused confusion: only one-quarter knew that it signifies the last date for use of the product at its peak quality. Nearly a third (30.4%) believed that it was the last date the product was edible, almost a quarter (22%) thought it meant that it was the last date the food product could be displayed and sold in a store, and finally, 21% thought it meant the date that the product would be at its best flavor and quality - when, in fact, this

is the 'best-by' date (interestingly, while these guides are in place, they don't actually say that this is the last date a product can be eaten by - that part is up to you, the consumer. You can eat something beyond the guidelines, but just give it a check over, or a 'sniff test' first before eating).

Over half (51.1%) of people believe that best before dates on fruits and vegetables should be scrapped altogether because they say it's easy to tell if something has gone off just by touching it. The survey also found that the foods Americans would be most likely throw away are dairy products (46.6%); followed by meat (22.3%); fish (19.2%); bread (5.1%) and vegetables (8.5%).

Cherry Digital have provided advice below on how you can be more resourceful with your food, and so hopefully will be able to throw less away in the future:

Freeze your food. You can actually freeze the food right up till the use-by date, and it will be good to eat months later! (Just double check what you can or can't freeze - not everything can go in, like soft cheeses).

Freeze milk into an ice cube tray! As the survey revealed, most people will throw away dairy products first - well now they can use this handy tip instead of wasting. Use the frozen milk cubes in coffee or tea!

Put your herbs into a glass of water to prevent them from wilting quickly, they will last much longer!

If yogurts are getting near their use-by date, you can mix them up with some over-ripe fruit for a smoothie or even freeze into ice-lollies!

Turn stale bread or crusts into breadcrumbs by putting them in a food processor. Fantastic when mixed with herbs or onions as a stuffing for chicken or to top baked fish!

When cooking with foods such as potatoes, broccoli, or carrots, use it all. You don't need to remove the peel or cut the stems off, as they often have additional nutrients in! And if you don't like the peel or stem, you can compost what you don't use.

Donate the items you might be close to throwing out which aren't yet out of date. There will be plenty of food kitchens nearby that would really appreciate anything you have which is going spare.





THE HILLS MANSION By: Lucie B



When driving on Washington Street, there are two massive granite gate posts on the corner of Washington and Hillscrest Road. They were built in the 1890s. It was the entrance to the Edwin Hills Mansion. Hillscrest Road was not in existence in the 1890s.There were also iron fences on the estate attaching to each post. All you can see now is where the scars of the fences bordered the property.

At 15 Washington Street in Plainville, sat a beautiful mansion that belonged to Mr. Edwin Hills. It was built in 1872, shortly after Mr. Hills married Miss Emma Bullen. The couple had one son, Edwin Hiram Hills, born in 1883. Edwin Hills Sr., died in New York City in 1909. His son passed away in 1927 in Connecticut. Emma and her daughter-in-law and grandchildren continued to live at 15 Washington Street. The home/estate was sold in August, 1952.

On October 18, 1952 Carl W. Hartmann, Auctioneer and Appraiser, held an auction including antiques, modern furnishings, kitchen wares, and garden tools at the former Hills Washington Street home. Lunch was served on the premises. According to the 1953 Plainville City Directory, Mrs. Emma Hills and her family were living on Welch Street in Plainville. In March 1953, construction of the homes that now stand on Hillscrest Road began. The two granite pillars were to remain in place. They served as a reminder/memorial to the family that used to live on the Hills estate. There used to be a decorative ball that sat on the top of each pillar. They were removed and set aside during the construction on the estate. And since then, the ornaments went missing. HISTORIC NOTE: The massive mirror hanging over the mantel in the Victorian Parlor at the Historic Center survives from the Edwin Hills mansion.

THANKSGIVING TRADITION



Front and center downtown Plainville, the kitty-corner wooden green screen door with the metal pull, slams shut behind us as we enter. Oh, that aromatic sweetness. It's Saturday and always busy. Inside, a smiling Ma "Helen" Rogers, in her big white apron greets us. She's placing cookies on huge sheets to be baked, all the while waiting on folks, who suddenly feel hungry.

Mrs. Rogers mentored a succession of local teenagers who worked part-time after school and on weekends to help her dispense goodies and learned about responsibility, serving the public, and the joy of earning their own money.

We remember, white mountain bread, Thanksgiving pumpkin pies, (perfectly spiced), apple and mince, too.

On Fridays there was Yankee pizza, plain cheese and sauce on thick Rogers bread dough, sold in big squares. Who can forget the honey dipped donuts for a nickel? What was your favorite?

It's Saturday late afternoon and people are picking up their bean pot full of Rogers' recipe baked beans. They were sold by the pound in containers, of course, but if you left your pot on Friday, the baker would fill it for you and place it separately in the big oven. That oven produced more gas over the years than the Atlantic pipeline.

Then, of course, were personal birthday cakes and those "made to order" elegant wedding cakes.

These cookies were baked every election day in colonial America.

1/3 cup hot water	3 1/2 -4 C flour
2 tbs. rum	1/8 tsp. salt
1 tsp. baking soda	1 tsp. ginger
1 C molasses	¹ / ₂ tsp. powdered cloves
1 C sugar	¹ / ₂ tsp. ground nutmeg
1 C butter	¹ / ₂ tsp. allspice


Stir the rum into the 1/3 cup hot water and set aside. Stir the baking soda into the cup of molasses and set aside. In a large bowl, cream sugar and butter until light and fluffy. Sift dry ingredients together and add to sugar-butter mixture. Blend in hot water/rum, then soda/molasses. Cover bowl with damp cloth and refrigerate overnight. Roll out dough on pastry cloth or lightly floured surface to 1/4 or 1/2 inch thickness and cut into rounds with 4" cutter. Bake at 375 for 10-12 minutes.

Maine Shooting Suspect Found Dead

The man accused of killing 18 people in Lewiston, Maine, was found dead; he appeared to have died from a self-inflicted gunshot wound.

Robert Card's body was found next to a dumpster at a recycling plant he previously worked at in Lisbon Falls, ME, about twenty minutes from the scene of Wednesday's mass shooting.

Card's vehicle was found seven miles southeast of Lewiston, next to a boat launch, where police believe he boarded a jet-ski and made his way down the river to Lisbon Falls.

All 18 victims of the shooting have been identified. Their ages range from 14 to 76.

Robert E. Lee's Statue Melted Down

A statue of Confederate General Robert E. Lee was melted down at a secret ceremony, part of a project called Swords into Plowshares.

Plans to remove the statue sparked the Unite the Right rally in 2017, and the removal was completed four years later. A team from the University of Virginia and a local museum created the plan to melt the statue into bronze ingots and create a new piece of public art.

The plan was kept quiet in order to avoid "threats and legal action," according to one report.

The most current cost of the project is \$61,913,406.

Does the Town receive a reimbursement from the State?

ANSWER

The town is projected to receive 65.36% reimbursement for eligible expenses. The local cost is projected at \$26,245,088. However keep in mind the actual local cost including interest for 20 years will be **\$41 million.**



The PAWS clothing drive continues through November.


We were so pleased to greet those who stopped by our table at the PumpkinFest. Your continuing interest is so very much appreciated and our report for this month highlights how much your support benefits animals who are in desperate need of help. Recently we have had a rash of "foundling animals."

Autumn weather, and later on, winter brings great challenges for animals in distress. The abandonment of pets is always unnecessary in Plainville, but during severe weather conditions this becomes life threatening to a completely defenseless domestic animal.

In the interest of safety, all around, you should know that you can surrender your pet under emergency circumstances to your Animal Control Officer, without question. That being said, some information about your pet will help to settle it into a new home; for instance, its name and age, any medical history, quirks, food preference, etc. We will help you provided your animal is not unruly or unmanageable. In that case, you should contact your Veterinarian. If you need advice, we may be able to guide you. If you are facing a "rough patch" and not able to keep your pet, let us know and perhaps we can work something out so that you can keep your pet or it can have some type of interim care.

Recently we have been able to find new happy homes for three orange kittens and two adult dogs. All animals taken in by Plainville PAWS and Plainville Animal Control are vetted prior to meet and greets or adoptions.

We are pleased to report that our Princess, now Sophie, has adjusted and is doing well in her happy forever home. She has completely recovered from her corrective surgery and completed her intensive physical therapy program, all provided by you. Grateful for her good health, she enjoys a good brisk autumn walk and sends best wishes for a Happy Thanksgiving to the people of Plainville, along with those from all of your Animal Control staff.





DOG LICENSING REMINDER TOWN CLERK'S OFFICE

The Town Clerk's Office is reminding dog owners that all dogs over 6 months old must be licensed by June 30 for the 2023-2024 year.

Renewals may be done in person, by mail, or online if the rabies vaccination is current. If the rabies information is not current, owners must submit the updated rabies certificate for the license to be processed. The cost of a dog license is \$8 for a neutered or spayed dog and \$19

for non-altered dogs. After June 30, a penalty charge will be imposed of \$1 per month for each month that the dog is not licensed.
